#### REFLECTIONS ON ANNUAL CONFERENCE BY: ANN YELLE...LAY MEMBER TO ANNUAL CONFERENCE

The 2023 Wisconsin Annual Conference of the United Methodist Church was held on June 8-12 in Green Bay, Wisconsin. Prior to these dates, I participated in two preconference virtual training sessions. I have been a lay member for about 15 years. I have found this to be a valuable experience for learning about the United Methodist Church and for meeting other loving people. It is my belief that one needs to be a lay member to Annual Conference a number of times to really understand what is happening in the United Methodist Church. The theme for this year's conference was, "On Earth as it is in Heaven"-Engaging in Transformative Community Building. This is based on Philippians 2 which tells us that it is God's intention that all people engage in fruitful work of transformation. One-third of the lay members participated on-line yet this year. Next year all members will be attending in person.

The plenary sessions (another word for the business of the church) were quite ordinary again this year. Four churches were discontinued: Bashford UMC, Madison, WI; Wellspring UMC, Madison, WI; Wittenberg New Horizons UMC, Wittenberg, WI; and Beetown UMC, Beetown, WI.

We were updated via reports and presentations from various committees, boards, ministries, etc., that operate within the Wisconsin Conference or are in partnership or supported by the Conference. The United Methodist Church is a connectional church and as such we are involved in many areas locally and throughout the world. A delegation from Dongbu Conference, with whom the Wisconsin Conference has had a relationship for 20 years, was present at our conference Next year the Wisconsin Conference will send delegates to the Dongbu Annual Conference in South Korea.

Global Ministries, an arm of the United Methodist Church, provides mission outreach. As part of Global Ministries, the Wisconsin Conference has sponsored local churches in Bolivia. Since 2021, six motor cycles were purchased to assist in mission work in remote areas of Bolivia. Presently, sewing machines are being collected and sent to Bolivia. Global Ministries supports 15 missionaries throughout the world. Dignity Kits, collected for Midwest Distribution Center, totaled 1,456 kits or 15,720 pounds. We, at Our Savior's UMC and Gilmanton UMC, provided 52 kits. These kits will be sent to those in need throughout the world as part of Global Ministries' work. As John Wesley said, "The world

Voting matters included the disaffiliation requests by 43 churches. Specific requirements for disaffiliation were fulfilled by them. These churches had decided they could not live as part of and express their faith in the United Methodist Church. This is due to the changes in the church DISCIPLINE regarding the matter of human sexuality. Preceding the vote reading, Bishop Jung shared the need for us to respect the discernment that had taken place.

"It is not a time for taking sides, expressing anger, or cheering, or clapping. It is a time for prayer and generous care for one another." The vote to allow these churches to disaffiliate was 93.5 percent yes and 6.5 percent no. No church in our District, the North West District, disaffiliated. The disaffiliated churches no longer have pastoral leadership from the United Methodist Church effective July 1. The Wisconsin (continued on page 3)

At the ordination service on Sunday, it was a special time to see Rev. Ho Lee, who invited us to Wisconsin, ordained as an elder pastor. I'm grateful that the Harmony Choir I'm in performed well. #### Secretary's Report

Ann Yelle reported a correction to the ending balance for April 2023 in the Memorial Report which should be \$19,162.64. Julie Brunsch also reported that Jay Branger's name was missing from the May report as attending the meeting

Motion to accept the May 2023 Secretary's Report with the above changes was made by Kolleen Branger and seconded by Julie Brunsch. Motion carried.

#### Finance Committee (Jay Branger, Chair)

Jay reported the Finance Committee had met and developed a Church Funding Contingency Plan as follows:

The Our Savior's Church Finance Committee recommends the following Contingency

Funding Plans if weekly offerings are insufficient to meet local operating expenses

#### Short-Term Funding Plan

Plan A – Use \$12,000 of money designated as Christmas Walk funds (\$8000 in checking account and \$4000 in the account administered by Jan Bechel). Profits from the 2023 Christmas Walk will be added to these funds later in 2023.

Plan B – Once the Christmas Walk money is depleted, use \$2020 designated to New Ministries.

Plan C – Once the New Ministries Fund is depleted, use funds in the Undesignated Memorials Account totaling approximately \$3500.

Funds in the Tom Cook memorial will be used to pay for the kitchen cabinet improvements related to F3.

Funds in the Sunday School and Youth Fellowship accounts will be used for F3 expenses.

The Finance Committee will determine if church maintenance expenses should be funded by other memorial accounts on a case-to-case basis.

#### Funding Plan for 2024 and beyond

Share pastoral expenses with another church besides Gilmanton. Chairman Dave Boley will contact the District Superintendent to set up a meeting to discuss this option further. Without this action, it will be difficult for Our Savior's Church to remain in existence once the funds referenced in the Emergency Funding Plan referenced above are depleted.

The earliest we likely could begin partnering with another congregation to share pastoral expenses is in July 2024 after the annual conference.

Discussion ensued regarding the Short-Term Funding Plan.

Motion to approve Plan A through Plan C in the Short-Term Funding Plan was made by Jim Williams, seconded by Jan Bechel.

Motion to approve the remaining three bullet points in the Short-Term Funding Plan made by Jim Williams, seconded by Jan Bechel. Motion carried.

Discussion ensued regarding longer term funding. Dave Boley will follow up.

Motion to move forward with the funding plan for 2024 and beyond made by Jim Williams, seconded by Jan Bechel. Motion carried.

Jay presented the following message that will be published in the July newsletter, church bulletin and website.

Happy summer! I hope this message finds everyone enjoying summer and time spent with family and friends. The summer months often reduce Church attendance due to weekend activities and personal travel. As a

result, weekly offerings typically decline and the Church's ability to pay monthly expenses becomes more difficult. This year is no different as we have used nearly \$7000 of emergency funds through the first five months of the year to meet our local operating expense needs. We need everyone's help in keeping our monthly expenses paid and the Church financially sound. This can be accomplished by contributing to the offering during Sunday services, mailing funds to the Church office, or by making an electronic payment via the offering line for Vanco at tp://secure.mvvanco.com/L-Z3D4/home There is also a GIVE button on the Church website home page that will take you directly to the site. The address for the Church website is www.oursaviorsumc.org.

My goal is for all of us to increase our offerings to eliminate using our emergency funds to keep our expenses paid since this source of funding is limited and quickly decreasing. I hope and pray you will remember the Church and its financial needs as you go about your daily lives as the Church is always here for you to provide spiritual assistance and support during times of need. There is an old saying that many hands make light work! I am convinced that if we all pitch in, the financial needs of the Church will be met! In God we

(continued from page 2) Conference will reach out to those from the disaffiliated churches who want to continue to be United Methodists, helping them connect with a new United Methodist Church. At this time it is unknown how actions taken by the General Conference, when it meets in the spring of 2024, will affect disaffiliation actions previously voted on by them. General Conference's decisions become part of the DISCIPLINE and affect every conference worldwide. Due to COVID, General Conference did not meet on schedule. They are to meet every four years.

Conference statistics were given. These come off of the EZRA report that churches need to submit electronically by February of each year. Information gathered showed that Wisconsin had 448 local churches with 77 per cent submitting their information on time. It was noted that membership trends are down. The Wisconsin conference has 42,000 members. Of this number 2/3 of the members are attending 1/3 of the churches. From the information gathered by this report, all churches would receive a "D" in Outreach Ministry. Only 65 per cent of churches reported doing Outreach.

Appointments of District Superintendents took place. The North Central District, of which we are a part, will have Rev. Peace Kim as our new Superintendent. He replaces Rev. Barbara Certa-Werner. He and his family will reside in Eau Claire. Plans continue for the combining of Northern Illinois and Wisconsin into one conference. Bishop Jung continues as Bishop in our Wisconsin Conference.

Activities that we shared in included an excellent Bible Study, worship, communion, singing, praying, meeting new people, etc. In addition, we shared in a Service of Remembrance, where persons connected to the Wisconsin Conference, who have died since the previous Annual Conference, are honored. We also honored pastors for their length of service, beginning at 25 years. One pastor was honored for 74 years of service, the longest number of years. The names of clergy retiring were read. If I counted right, these numbered twenty-three. Changes in appointments, to begin July1, were read. Five of the churches received a pastor from the Philippines. This is the first time pastors from the Philippines have been assigned to Wisconsin Conference churches. At the time of Annual Conference some churches had yet to be supplied pastors.

As at other Annual Conferences, the Recognition, Commissioning, and Ordination Service continues to be a very special service. This included four, to be licensed as a local pastor, three who had completed the course of study for a licensed local pastor, and one who was an associate member. Additionally, two were commissioned as an elder, two ordained as an elder, one ordained as a deacon, and five were transferred in. Adding to my love of this service, was the singing by the Harmony Choir, of which our own pastor, Pastor Kim, was a member.

I again thank you for the opportunity to represent Our Savior's and Gilmanton Churches at Annual Conference. I continue to pray for our local churches, and also the United Methodist Church throughout the world. May we be a church that loves all. Let us make disciples of Jesus Christ for the transformation of the world. Let us proclaim love in every corner of the world. "Peace, I leave with you. My peace I give to you." John 14:27
