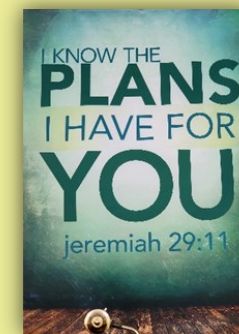
Pastor's Corner

We pass many people during the day, most of whom are strangers. We don't know each other, so it may not be considered our happiness even if they are happy. The same goes even if they are unhappy. But if we know someone, it's different. We feel compassion for what they are going through, and sometimes it breaks our hearts or makes us happy. This is because knowing someone's name means that a relationship has begun.

Meeting called to order by Chairperson Dave Boley.

Council members read Break-through Prayer in unison.

Next Meeting: August 16, 2023, at 6:00 p.m.

Secretary's Report

Motion to accept June 2023 Secretary's Report made by Kolleen Branger and seconded by Julie Brunsch. Motion carried.

Finance Committee (Jay Branger, Chair)

Regarding the letter Jay drafted regarding finances, Jay inquired if this should be mailed to members. Discussion ensued, and will be discussed further at the August meeting.

Jay inquired if a meeting had been scheduled with District Superintendent Peace. Dave Boley will be in contact with District Superintendent Peace regarding setting up a meeting.

Executive Summary (Julie Brunsch, Treasurer)

Checking account totals are as follows: Beginning balance of \$13,184.40; deposits of \$7164.64; interest of \$7.83; expenditures of \$10,888.40; uncleared transactions of \$0.00 with an ending bal-

ance as of June 30, 2023, of \$9468.47. Checking account reconciled with bank statement. Internal account balances are Checking \$49.49; Elevator Repair \$524.00; Local Disaster \$390.00; New Ministries \$2019.80; Christmas Walk \$5400.00; Scholarships/Youth Awards \$260.00; Sunday School \$825.18 for balance of \$9468.47. Other accounts: Building/Restoration \$1971.64; Youth Fellowship Account \$4249.34.

Julie used \$2600.00 from Christmas Walk Fund to cover June shortfall.

Servant Keeper has informed us they are raising their rate from \$29.99 per month to \$39.99 per month.

Current checkbook balance is \$3672.69 with bills of \$5033.64 due by end of the month. Julie reported the income thus far for the month of July is way up.

Julie received a request from the Mondovi Police Department for a donation for child safety education kits and program literature at a cost of \$4.00 per child. Ann Yelle made a motion to donate \$100.00 from the Youth Fellowship Account. Motion seconded by Linda Johnston. Motion carried.

Memorial Report (Ann Yelle, Chair)

Balance as of May 31, 2023, \$19,191.30 with credits of \$7.89 interest and no debits with end-

ing balance of \$19,199.19.

Finance Secretary (Kolleen Branger)

Kolleen reported she has successfully completed the quarterly statement for April through June.

The loose cash from the service at the Gilmanton Park on Sunday totaling \$40.00 is going to F3.

Motion made by Jim Williams and seconded by Sonny Sandberg to accept the June 2023 Executive Summary, Memorial Report and Finance Secretary reports. Motion carried.
