

OUTREACH **Pastor's Corner**

Dear Friends.

For the first time since moving to Wisconsin, I've started farming in the backyard garden at the Colfax Parsonage. A few weeks ago, my wife and youngest son pulled all the weeds, tilled the soil and planted strawberry roots. Later, my wife and I planted vegetable seeds that we had been saving for a while - sesame, leeks, green onions, peppers, lettuce, and pumpkins. I actually never farmed when I lived in Korea. I only planted two or three vegetables a few times since coming to the US.

Once I planted the seeds, I wondered when they would sprout, so when I went to Colfax, I would look into the garden in the morning. It's been about three weeks now, and I've seen some tiny sprouts, but I can't tell if they're weeds or the sprouts of the vegetables I planted. But as long as I water the seeds in time and take care of them so that rabbits and birds don't come and eat them, I'm sure I'll be able to enjoy fresh vegetables from my garden this summer.



I had to search every nook and cranny of the house to find the seeds to farm this time because when I moved to Wisconsin last year and unpacked, I couldn't remember where I put them. Most of the seeds were given to us by someone a long time ago. Some were over a decade old. When we put them in the ground, they sprouted. No matter how old a seed is, if you plant it, it will sprout. Until 32,000-year-old seeds of a plant were discovered in 2012, the oldest seeds in the world were date palm seeds found in 1963 during excavations at Masada, an archaeological site in Israel. The seeds were dated to be over 2,000 years old. The scholars who found them planted some of them and named a date palm tree that grew from one seed Methuselah, the oldest living person in the Bible. The tree is now three meters tall. The vitality of the seed is amazing.

Methuselah

The Bible is full of stories about seeds and farming. Jesus says that the seed sown in good soil will bear fruit at least 30 times and up to 100 times (Mark 4:8, Matthew 13:8, Luke 8:8). The seed here is the Word of God. In this parable, Jesus says, "...as for what was sown on good soil, this is the one who hears the word and understands it, who indeed bears fruit and yields in one case a hundredfold, in another sixty, and in another thirty" (Matthew 13:23). In Mark's Gospel, Jesus describes the kingdom of God this way: "The kingdom of God is as if someone would scatter seed on the ground and would sleep and rise night and day, and the seed would sprout and grow, he does not know how" (Mark 4:26-27).

What if I planted a seed in my garden and it didn't sprout? We may be worried that the seeds of God's Word that we have sown will not bear fruit. We may look at ourselves and think, "Why haven't I seen any fruit since I believed in Jesus?" or "Why haven't I seen any change in someone with whom I shared the gospel?" However, God's seed does not change over thousands of years. When it falls into the right field, it sprouts, dispelling darkness, giving eternal life to those who believe in him, and producing abundant fruit of life. If a seed is planted, it will sprout and bear fruit even if it may be slow. The seed is growing even while we are not aware of it. God wants the seed to grow more than anyone else, so we must continue to sow the seed, God's Word, into our hearts and into the next generation. God, the most excellent farmer, will make sure we see good fruit. The psalmist confesses, "Those who sow with tears will reap with songs of joy. Those who go out weeping, carrying seed to sow, will return with songs of joy, carrying sheaves with them" (Psalm 126:5-6).

In regard to the Financial Secretary position, Kolleen reported that Jay Branger had volunteered to do some of the Financial Secretary duties, but after they discussed further, Kolleen has proposed to resign as Finance Chair and Jay Branger would take over the position as Finance Chair and Kolleen will accept the position as Financial Secretary. Debbie Duncanson made a motion to accept the proposal. Ann Yelle seconded. Motion carried.

Executive Summary (Julie Brunsch, Treasurer)

Checking account totals are as follows: Beginning balance of \$17,737.17; deposits of \$11,112.73; interest of \$9.87; expenditures of \$12,788.16; uncleared transactions of \$589.11 with an ending balance as of March 31, 2023, of \$15,482.50. Checking account reconciled with bank statement. Internal account balances are Checking \$363.52; Elevator Repair \$524.00; Local Disaster \$390.00; New Ministries \$2019.80; Christmas Walk \$11,000; Scholarships/Youth Awards \$260.00; Sunday School \$925.18 for balance of \$15,482.50. Other accounts: Building/Restoration \$1967.76; Youth Fellowship Account \$4240.98

Julie reported to meet a shortfall for

bills for March she used \$1566.00 from the Christmas Walk fund. She paid \$125.00 from the F3 account for the fair booth.

The elevator permit has been approved until May 30, 2024.

Julie reported there is an IRS issue with the 4th quarter 941 showing we owe twice as much as was paid. Julie is questioning if they ran the 941 through twice and Julie will be following up on this.

Julie will be issuing a corrected W2 to Pastor Kim.

Current checkbook balance is \$-2580.69 with bills due by end of the month of \$2439.40.

Memorial Report (Ann Yelle, Chair)

Balance as of February 28, 2023, \$18,552.72 with credits of \$167.84 and debits of \$410.00 with ending balance of \$18,310.56. 
