Highlights from the Council Meeting—October 19, 2023

Council members present: Pastor Kim, Dave Boley, Jay Branger, Kolleen Branger, Ann Yelle, Sonny Sandberg, Linda Johnston, Dora and Randy Johnston, Jim Williams, Jan Bechel.

Meeting called to order by Chairperson Dave Boley.

Breakthrough prayer read in unison by Council members.

Next Meeting: November 16, 2023, at 6:00 p.m.

Secretary's Report

Motion to accept September 2023 Secretary's Report made by Kolleen Branger and seconded by Jim Williams. Motion carried.

Use of Church Facilities

The Council met with Kim Negus, music therapist, regarding the possibility of Kim using the church facilities for music therapy. She presented pamphlets on the Listening Program and Interactive Metronome. Music therapy is a program through the County for autism, anxiety, and ADHD.

Kim indicated the best day of the week would be Tuesday from approximately 2:30 to 7:00 p.m. It is one-on-one therapy which lasts approximately 40 to 45 minutes per child.

Kim indicated she carries liability insurance. She also indicated there is a fairly imminent need.

After thanking Kim for the presentation, discussion ensued within the Council with the following questions:

Would we need to obtain approval from the Conference.

Would there be coverage under the church's liability insurance.

Would there need to be a contract.

Should there be rent charged to cover increased costs to the church in regard to electricity, heating, etc.

Dave Boley will be in contact with the Conference regarding the questions for approval, contract and rent, and Jay Branger will contact Church Mutual Insurance regarding the liability insurance questions.

Discussion was held regarding a request from a community member to hold a daycare in Our Savior's. Dave Boley met with the community member to show her

the church facility and answer any questions. Dave reported to Council members regarding these visits. Discussion ensued. Jay Branger made a motion to decline the request for a contract for daycare in Our Savior's. Ann Yelle seconded. Motion carried.

Finance Committee (Jay Branger, Chair)

Jay presented the 2024 preliminary budget, and indicated Julie Brunsch and himself would review and present to the Council at the November meeting for approval. The major increases include the Pastor's salary and property insurance costs.

Executive Summary (Julie Brunsch, Treasurer, absent)

Kolleen Branger presented the Executive Summary information in Julie's absence.

Checking account totals are as follows: Beginning balance of \$16,554.59; deposits of \$9921.79; interest of \$10.38; expenditures of \$10.977.24; uncleared transactions of \$332.46 with an ending balance as of September 30, 2023, of \$15,177.06. Checking account reconciled with bank statement. Internal account balances are Checking \$5718.16; Elevator Repair \$524.00; Local Disaster \$390.00; New Ministries \$2019.80; Christmas Walk \$5400.00; Scholarships/Youth Awards \$260.00; Sunday School \$865.10 for balance of \$15,177.06. Other accounts: Building/ Restoration \$1975.57; Youth Fellowship Account \$4157.66.

Kolleen reported per Julie a correction to the August Executive Summary in the beginning balance of the Building/ Restoration Account. The beginning balance should have been \$1972.96 and ending balance \$1974.29.

Current checkbook balance is \$6753.95 with bills due of \$8823.14.

No Christmas Walk funds were used in September.

Memorial Report (Ann Yelle, Chair)

Balance as of August 30, 2023, \$19,215.50 with credits of \$7.63 and no debits with ending balance of \$19,223.13.

Ann presented a corrected August Memorial Report to show a credit of \$8.16 instead of a debit of \$8.16.

<u>Finance Secretary</u> (Kolleen Branger)

Kolleen reported that the third quarter




