








Wednesdays April 2, 9 & 23 12-1 pm at Our Savior's UMC

Secretary's Report

Motion to accept January 2025 Secretary's Fellowship Account \$4197.28. Report made by Julie Brunsch and seconded by Linda Johnston. Motion carried.

Finance Committee (Jay Branger, Chair)

Jay reported he talked to Sarah Snyder from the Conference regarding an email stating there could be possible financial help from the Conference for churches who receive a large increase in insurance premiums. Jay will be in contact with her again after the insurance renewals are completed. Current insurance payments will now be paid to the Conference.

Worker's Compensation payment is \$973.00 per year.

The conference is still working on finalizing the property, casualty and umbrella aspects of insurance.


