#### Pastor's Corner

This is a Lenten reflection by my wife, Pastor Jin. I hope it helps you in company with our Lord Jesus Christ in this Lenten season.

When we reflect on the passion of Jesus during Lent, we are often disconcerted by the passive suffering of Jesus, even though we know how it ends. Instead of the active Jesus who heals the sick, casts out demons, and speaks truth with authority to the hypocritical Pharisees, we are confronted with a seemingly helpless Jesus. Sometimes we feel like Peter, who couldn't accept Jesus' helpless suffering and death in the first place. Weakness is something that society discourages and something we don't want to experience. When we become old and weak or sick and frail, we may feel that we are useless.



When I had a cold recently, I was thinking, "I need to get better soon so I can do my job well," but as I rested, I realized that I needed to rest right now, and thanked God for allowing the cold to put the brakes on my busyness.

The other day I finally ate an old pumpkin that I had harvested last year. When I split the old pumpkin open, it was full of seeds. I had picked the others when they were young, but I left the one I wanted to get the seeds from until the end. The

pumpkin stayed where it was, through sunshine and storms. Though it looked like it was doing nothing, the seeds of new life were diligently growing inside it.

When we are sick, need to rest, and are unable to do anything, our body and soul are preparing the seeds of resurrection like the helpless Jesus in his suffering, like that old pumpkin that just sat still, unmoving in one place. If we are in Christ, we are new creations (cf. 2 Cor 5:17). Even as we age, we are being made new creations day by day. Even when the elderly no longer have an active social life and need to be cared for in a nursing home or at home, the seeds of resurrection are growing in them if we see through the eyes of faith. Ironically, it is in the most helpless situation on the deathbed that the saint fights the greatest battle. It is in anticipation of death that the seed of resurrection grows stronger within them. That is the moment to run the final stretch toward completion of renewal in Christ.



Whether we are in a nursing home or bedridden with a cold, COVID, or some other illness, let us remember that we are creating the seeds of resurrection. Let us pray the pumpkin prayer, tending to those seeds in quietness, whether in the sunshine or the rain, for that static place of prayer is indeed the most dynamic place.




